Rehearsal Dinner & Departure Brunch Questions

How do I hold my date?

Your date is secured once we receive the initial retainer and signed contract.

Do you require a security deposit?

Yes, a refundable \$1,000 security deposit is required. Your deposit will be returned within one week of your event, provided there is no damage and venue policies have been followed. Damages exceeding \$1,000 are the responsibility of whoever is contractually responsible for the event.

Are there any other expenses I can expect?

Only one on our end... all venue rentals require event insurance.

Is my venue rental fee refundable?

Retainers are refundable until 365 days prior to your event but are subject to a \$1,000 cancellation fee. Cancellations must be made in writing.

What if I need to change my date?

We will make every effort to assist you in date changes at least 365 days from your booked date. All date change requests must be submitted in writing and are subject to an updated contract. Rescheduled rentals are subject to the current pricing of the new date and may be higher than the original rate. The balance due for the entirety of the venue rental fee of the new date is due in full at the time of rebooking and is non-refundable. Date changes less than 365 days from the rental date are not permissible.

How do I pay?

Half of the venue rental fee is due at signing as an initial retainer. The other half is due nine months prior to your event. Any outstanding balance for, bar, refundable security deposit, services or rentals is due in full no later than two weeks before your event. All of these payments can be made on-line by credit card or ACH draft. Credit card payments are subject to a 3% service fee.

Can I bring my own alcohol?

No... all alcohol must be provided by Adams Estate.

What do I have to do at the end of my event?

We ask that you remove all of your personal items and any décor you would like to keep by the end of your rental period. Anything left on property, including florals and décor, may be disposed of.

What if I need more time before or after my event?

One additional hour can be reserved, in advance, at the rate of \$300 per hour.

How late can my event go?

The venue is open until 11:00 pm. Lake Alfred noise ordinances require amplified music end at 10:00 pm.

Will anyone from the Estate be there during my rental?

Yes, an Adams Estate staff member will be on property for the entirety of your rental.

What do I do if it rains?

Events in The Boathouse are held rain or shine.

What if there's a tropical storm or hurricane?

If there is a tropical storm or hurricane watch on the day of your event, you *may* reschedule without penalty. If there is a tropical storm or hurricane warning on the day of your event, your event *will* be rescheduled without penalty.
