

Cash & consumption bars are subject to a \$40 per hour, per bartender fee, with a minimum of \$160 per bartender.

Should you prefer to pay for the drinks served that evening, rather than selecting a per person package, your bartender will run a consumption tab. A deposit, based on your headcount and beverages you choose to offer, is required for consumption bars.

During peak season (October thru April), there is a \$2,500 beverage minimum for Fridays and Saturdays.

Day of Coordination ~ \$1,600

For all full day packages, a Day of Coordinator or Planner is required. We do offer Day of Coordination services, however, you are welcome to hire any coordination or planning company you prefer. For half-day packages without a Coordinator or Planner, we do require contact information for a lead person who will be responsible for all wedding day details including décor set up, ceremony direction, troubleshooting and questions.

Your Adams Estate Day of Coordinator and team is responsible for making sure your wedding day is executed perfectly. Their responsibilities include creation of your master timeline, overseeing vendors, managing the timeline, and overcoming any last-minute challenges that may arise.

Timeline Creation

With your input, your Coordinator will develop a master timeline for your wedding day. The master timeline will include the arrival time of the wedding party, the arrival time of all vendors, the photography timeline details you have previously arranged with your photographer and the entertainment timeline details you have previously arranged with your DJ.

The master timeline will also include your rental start and end times, your ceremony start time and the evening's grand exit time. Your master timeline will also include additional details you are planning such as welcome speeches, blessing of the food, toasts, dances, cake cutting, bouquet and/or garter tosses and any other special moments of the day you would like included.

Ceremony Rehearsal

Your Coordinator will conduct your ceremony rehearsal (up to one hour) at the Estate. If there is a wedding booked on your rehearsal day, the rehearsal will be conducted at the hilltop pool overlooking the lake.

Wedding Day Services

Members of your day of coordination team will be on hand for the entirety of your wedding day. Your Coordinator and coordination team will provide:

Questions

How do I hold my date?

Your date is secured once we receive the initial retainer and signed contract.

Can I bring in outside catering?

With the exception of your wedding cake / desserts and your day-of dressing room food, all catering for your reception must be provided by one of our two approved caterers.

Can I bring my own alcohol?

No.. all alcohol must be provided by Adams Estate including in the Groom's Loft and Bridal Suite.

How do I pay?

Half of the venue rental fee is due at signing as an initial retainer. The other half is due nine months prior to your event. Any outstanding balance for bar, refundable security deposit, services or rentals is due in full no later than two weeks before your event. All of these payments can be made on-line by credit card or ACH draft. Credit/debit card payments are subject to a 3% service fee.

Will the prices quoted on this sheet remain the same?

All prices for services and rentals included in a signed contract are confirmed. As we continue to add amenities, our prices are subject to change.

What if I need to change my date?

We will make every effort to assist you in date changes at least 365 days from your booked date. All date change requests must be submitted in writing and are subject to an updated contract. Rescheduled rentals are subject to the current pricing of the new date and may be higher than the original rate. The balance due for the entirety of the venue rental fee of the new date is due in full at the time of rebooking and is nonrefundable. Date changes less than 365 days from the rental date are not permissible.

Is my retainer refundable?

Retainers are refundable until 365 days prior to your event but are subject to a \$1,000 cancellation fee. Cancellations must be made in writing.

Do you require a security deposit?

A refundable \$1,000 security deposit is required. Your deposit will be returned within one week of your event, provided there is no damage and venue policies have been followed. Damages exceeding \$1,000 are the responsibility of whoever is contractually responsible for the event.

Are there any other expenses I can expect?

Only one on our end... all rentals require event insurance.

Will anyone from the Estate be there during my rental?

Yes, an Adams Estate staff member will be on-site for the entirety of your rental.

What do I have to do at the end of the evening?

We ask that you remove all of your personal items and any décor you would like to keep by 11 pm. Anything left on property that evening, including florals and décor, *may* be disposed of. Staircase floral installation removal is subject to an additional \$150 fee.

How late can my reception go?

The venue is open from 8 am to 11 pm. Lake Alfred noise ordinances require amplified music end at 10 pm.

What if I need more time before or after my event? Additional hours can be reserved, in advance, at the rate of \$500 per hour.

What do I do if it rains?

This is Florida, so rain is always a possibility. Your rental includes a luxury 40 x 60 glass enclosed, climate-controlled tent on the east terrace. For events with over 150 guests, we strongly recommend reserving/renting an additional tent for the open-air terrace.

What if there's a tropical storm or hurricane?

If there is a tropical storm or hurricane watch on the day of your event, you *may* reschedule without penalty. If there is a tropical storm or hurricane warning on the day of your event, your event *will* be rescheduled without penalty.

Can we dance outside?

With the exception of ceremony and cocktail hour music, all amplified music must be in the glass enclosed tent.

Can my videographer use a drone?

Drone photography is allowed. All drone operators are required to have a valid FAA drone license or certificate.
