Lodging Details

- Saturday venue rentals ~There is a two night minimum for Saturday rentals and a buyout is required of all units. Your guests may pay for their own reservations.
- Friday venue rentals ~ Lodging is not available
- Sunday thru Thursday venue rentals ~ No nightly minimum or buyout is required. Custom lodging blocks are available.
- Check in is 3:00 pm. Check out is 10:00 am.
- Early check ins & late check outs are available upon request, but not guaranteed.

Day of Coordination Services

A Day of Coordinator or Planner is required for all weddings at the Estate. While we do offer coordination services, you are welcome to hire an outside vendor.

Your Adams Estate Day of Coordinator and team are responsible for making sure your wedding day is executed perfectly.

Vendors

We can provide you with an extensive list of excellent *recommended* vendors. Any vendor you choose that is not on our list must provide a current Certificate of Insurance.

- Alcohol: To maintain the integrity of our liquor license, all alcohol must be provided by Adams Estate.
- Catering: With the exception of your cake, all catering services must be provided through Adams Estate.
- Floral: All floral and décor must be installed by a licensed and insured vendor.
- Music: While not required, we strongly encourage the use of Graingertainment for your DJ services. Bands are permitted. With the exception of ceremony and cocktail hour music, all amplified music must be in the glass pavilion and must end by 10 pm.
- Photo: All photography, videography and drone service must be provided by a licensed and insured vendor. Drone operators must provide a current FAA drone license.
- Tents: For events with over 150 guests or a band, we strongly encourage the reservation of a tent and connector for the Terrace. Installation of an optional tent must be approved by the Estate and performed by a licensed and insured vendor. Scheduling of the installation must be confirmed in writing by your Adams Estate Liaison or Coordinator.

Frequently Asked Questions

How can I schedule a tour?

Visits to the Estate are by appointment only. Please call 863-450-9201 to schedule yours. Tours are conducted seven days a week, as long as we are not hosting an event.

How can I reserve a date and how do I pay?

Your date is confirmed upon receipt of digital approval of your rental contract and a retainer equal to half of your base venue rental fee. The balance of the venue rental fee is due nine months prior to your wedding. Your final payment is based on your actual headcount and is due two weeks prior to your big day. We accept all major credit cards and ACH payments. All card payments, whether debit or credit, are subject to a 3% convenience fee.

Is my retainer refundable?

Retainers are refundable until 365 days prior to your event, but are subject to a \$1,000 cancellation fee. Cancellations must be made in writing.

Are prices ever reduced or changed?

Our pricing structure may fluctuate based on current availability.

Do you require a coordinator or planner?

A Day or Coordinator or Planner is required. Adams Estate does provide coordination as an enhancement, but you are welcome to hire an outside vendor for this service. We ask that you have a coordinator or planner on your team no later than three months out from your wedding.

Are there any other venue related expenses I need to plan for?

Event liability insurance is required for all rentals. Adams Estate will secure this for you and add the actual cost, which is based on your headcount, to your final invoice. You can expect this cost to be between \$150 and \$200. Additionally, your final invoice will include a *refundable* \$1,000 damage deposit.

What do I do if it rains?

This is Florida, so rain is always possible. For events with over 150 guests, we strongly recommend reserving/renting an additional tent and connector for The Terrace. For events with 150 guests or fewer, ceremonies on inclement weather days will be held in the pavilion.

What if there's a tropical storm or hurricane?

If there is a tropical storm or hurricane watch on the day of your event, you *may* reschedule without penalty. If there is a tropical storm or hurricane warning on the day of your event, your event *will* be rescheduled without penalty.

What if I need to change my date or cancel?

Adams Estate will make every effort to assist with date changes more than 365 days from the reserved date. Rescheduled rentals are subject to the current pricing for the new date.

Events cancelled more than 365 days from the rental date are subject to a \$1,000 cancellation fee. Cancellations less than 365 days from the rental date are not permissible.

Each unit sleeps 2: ground floor, 1 king bedroom, 1 bath with shower, screened porch, Keurig coffee maker, mini-fridge, microwave

Gardner 1C & 1D and Burton 2C & 2D

Two night total with taxes & fees: \$661.92 per unit

Each unit sleeps 2: second floor accessed through interior stairwell (no elevator), 1 king bedroom, 1 bath with shower, screened balcony, Keurig coffee maker, mini-fridge, microwave

Majors Cottage 5

Two night total with taxes & fees: \$1,253.28

sleeps 4: 1 king bedroom, queen sleeper sofa in living room, 1.5 bath with tub and separate shower, full kitchen, laundry
